The Importance of CVAVAC:

The CVAVAC project, launched in February 2022 and running until February 2025, is a testament to what can be achieved when communities, partners, and stakeholders come together for a common goal. This initiative has been implemented across 14 Area Programs in 7 districts of Lesotho, reaching even the most rural and hard-to-access areas. It was further extended to the Thaba-Tseka district, where the need for child protection is profound.

The CVAVAC project embodies our mission to empower communities to advocate for improvements in the justice sector, with a specific focus on child rights protection. By implementing World Vision's Citizen Voice and Action (CVA) model, we ensured that local, district, and national structures worked in unison to address violence against children.

Achievements of the Project:

Today, we celebrate the tangible impact of the CVAVAC project:

Child-Friendly Spaces: Five children's courts, renovated and enhanced, now meet the
highest standards of child-appropriate infrastructure. These courts provide a safe and
welcoming environment for children navigating the justice system.

- **Innovations in Justice:** From video conferencing systems enabling privacy and accessibility to play therapy tools and furniture designed with children in mind, these courts are equipped to protect children's dignity and well-being.
- Capacity Building: Justice sector staff have been trained to effectively use these new systems and to approach cases involving children with sensitivity and care.

Highlighting Specific Contributions:

Let us briefly reflect on the transformations:

- Maseru Children's Court now boasts renovated park homes, access to the internet, and fully equipped play therapy tools.
- Tsifa Li Mali Children's Court in Leribe provides a warm, supportive environment where children can feel safe to share their experiences.
- Berea Children's Court has seen significant improvements, including electricity connection and enhanced visibility.
- Mohale's Hoek and Thaba-Tseka courts, in collaboration with UNICEF and the Government of Japan, now provide services that are both restorative and respectful of children's needs.

Impact on Children's Lives:

These changes are not just physical. They represent a commitment to ensuring that every child who enters these courts is met with compassion, respect, and support. These courts are a bridge to justice that safeguards their rights and preserves their dignity.

Looking Ahead:

As we inaugurate these child-friendly courts today, let us remember that this is only the beginning. The journey to eliminate violence against children and uphold their rights is long, but with projects like CVAVAC and continued funding from the European Union, we are making strides in the right direction.

We must continue to:

- Advocate for systemic change to sustain these improvements.
- Work together to protect children from harm and create a justice system that truly serves them
- Empower communities to amplify their voices in the fight against violence.
